CONDITIONS AND LIMITATIONS FOR RESIDENTIAL PARKING PERMITS

Applicants

A resident of Peppermint Grove may apply for a permit to park a vehicle on a thoroughfare provided the person is-

- (a) An occupier of a lot abutting that thoroughfare; and
- (b) The holder of the requisite vehicle licence (registration) under the Road Traffic Act for the vehicle; and
- (c) Described on the driver's licence as residing at the lot, or by signing this form you have acknowledged you reside at the lot.

Permit expiry

A permit issued may be either—

- (a) A permit issued for a period not exceeding one year and expiring on 31 December in the year of issue; or
- (b) A temporary permit issued for a period not exceeding 3 months from the date of issue.

Note: Should your residential address not be stated on your driver's licence only a temporary permit can be issued.

Temporary permits are not renewable or transferable.

Condition of exemption for residential parking permits

Where parking of a vehicle on any part of a thoroughfare is prohibited for more than a specified time the holder of a permit is exempted from such prohibitions if—

- (a) The vehicle is parked on a thoroughfare specified in the permit, but not adjacent to retail premises where parking of all vehicles is subject to time restriction;
- (b) The permit is affixed to the windscreen of the vehicle in a prominent position;
- (c) The permit has not expired; and
- (d) If the holder of the permit at the time of parking the vehicle still resides at the lot in respect of which the permit was issued.

Note: A residential parking permit does not exempt a holder from complying with the Shire's Parking and Parking Facilities Local Law. A vehicle left in a public place for a period exceeding 24 hours is deemed to be causing an obstruction and may be infringed.

Removal and cancellation of residential parking permit

- (a) The holder of a permit who changes place of residence or vehicle shall advise the local government and remove the permit from the vehicle to which it is affixed.
- (b) The permit shall be deemed to be cancelled on and from the date the holder changes residence or vehicle.
